

# Flexible Teaching and Assessment Strategies

## General Recommendations

While adapting your face-to-face courses to a [remote, web, or mixed mode learning environment](#) (synchronous or asynchronous), please bear in mind the following suggestions.

- Anticipate varying degrees of internet access and consistency for yourself and for your students.
- Avoid making assumptions about who will or will not have access to technology and internet resources. Create an opportunity for students to communicate their individual concerns (e.g., ask “Is there anything I need to know that could impede your continued progress in this course? ”). - To accommodate unexpected internet outages, modify your late policy, extend the amount of time to complete assignments or exams, or provide more than one attempt at an online exam to accommodate unexpected internet outages.
- Provide your students with options for accessing course content, demonstrating participation, completing assignments, and communicating with you.
- Establish a preferred means of communication and direct your students to use it. Consistent, frequent, and timely communication benefits everyone.
